

Whereas, vide this office Order No. 186 of 2020 dated 16-11-2020 issued under endorsement No. EC/Exc/Misc/F-008/4105-32 dated 16-11-2020 directions were issued in view of provision of Section 135C of Representation of the People Act, 1951 and request made by the Joint Chief Electoral Officer, UT of Jammu and Kashmir that liquor vends/ trades/ outlets selling liquor on/ off the premises operating within the Municipal Corporations/Councils/Committees in the Jammu & Kashmir shall remain closed as per the schedule of conduct of Municipal By-Elections, 2020 issued by the Election Commission, J&K; and

Whereas, the Chief Electoral Officer, UT of J&K vide Notification dated 23<sup>rd</sup> November, 2020 issued under No. 2173/CEO/ME/2020/1805-14 has rescheduled the conduct of elections for vacant seat in respect of 'Municipal Council Pulwama' from 4<sup>th</sup> Phase to 8<sup>th</sup> Phase; and

Whereas, the Joint Chief Electoral Officer, UT of Jammu and Kashmir vide letter No. 2134/CEO/ME/2020/1874 dated 26-11-2020 has enclosed the above notification and requested for issuance of corrigendum in this regard.

Now, therefore, in partial modification of Order No. 186 of 2020 dated 16-11-2020 issued under endorsement No. EC/Exc/Misc/F-008/4105-32 dated 16-11-2020, the dry days in respect of elections for vacant seat of 'Municipal Council Pulwama' shall be observed from **17-12-2020 (2:00 p.m. to 19-12-2020 (2:00 p.m.)** instead of 05-12-2020 (2:00 p.m.) to 07-12-2020 (2:00 p.m.). All the other directions with respect to observance of provision of Section 135C of Representation of the People Act, 1951 shall remain the same.
