**Subject:- Excise Policy 2022-23 -Relaxation thereof.**

**Order No. 09 EC of 2022**

**Dated 05-04-2022**

1. Whereas, as per Excise Policy 2022-23 issued vide notification No. SO 71 dated 22-02-2022 by the Finance Department, various locations for grant of Type-C (JKEL-2) were put on e-auction in UT of Jammu and Kashmir;
2. Whereas, the last date for submission of bid amount by the H1 bidders for e-auction 2022-23 was notified vide this office Order No. 329 EC of 2022 dated 10-03-2022;
3. Whereas, this office received representations from H1 bidders regarding extension of timeline for submission of property certificates / requisite documents.
4. Whereas vide this office letter No. EC/Exc/JKEL-2/e-auction 2022-23/9227 dated 29-03-2022, Finance Department was requested to issue directions to the concerned District Magistrates to expedite issuance of Property Certificates and Vend Clearance Certificates in favour of H1 bidders so that JKEL-2 vends could be made functional by 1-4-2022 in the interest of Government Revenue.
5. Whereas Finance Department vide letter No. FD-ET/27/2022-09/FD dated 04-04-2022 advised this office to settle the issue as per the Excise Policy 2022-23.
6. Whereas, as per clause 29 of the Excise Policy 2022-23,

***“the Excise Commissioner may relax the requirement of the time line for submission of formalities required for grant of license (JKEL-2) in exceptional circumstances considering the undue hardship caused to the successful bidders and the reason thereof shall be recorded in writing. However, the Excise Commissioner shall ensure that there is no court direction or order to the contrary before granting such relaxation.”***

Now therefore, as per advise received from Finance Department vide No. FD-ET/27/2022-09/FD dated 04-04-2022 and in the light of the powers conferred to the undersigned under clause 29 of Excise Policy 2022-23 issued vide SO 71 dated 22-02-2022 and in the interest of Government revenue, the timeline for submission of below

mentioned documents is hereby extended upto 20-04-2022 till 04:00 PM in favour of H1 bidders who have deposited the bid amount within the prescribed timeline:-

- I. Immovable Property Certificate. (As per clause 2.4.3 (3) of Excise Policy 2022-23 and clause VI (c) of Bid Document)
- II. Premises Clearance Certificate. (As per clause 2.4.8 of Excise Policy 2022-23 and clause IX of Bid Document 2022-23)
- III. Character Certificate. (As per clause 2.4.3 (5) of Excise Policy 2022-23 and clause VI (e) of Bid Document 2022-23)

This relaxation is however, subject to Hon'ble Court directions/order, contrary to it, if any.
