


TENDER NOTICE

For and on behalf of Government of J&K State, sealed tenders affixed with Rs. 5/= revenue stamp along with CDR worth Rs. 5,000/= (Rupees Five thousand only) invited from registered contractors/suppliers for hiring of labourers on the rates as approved by the State Government for operating of motor driven brush cutters during the poppy/ bhung destruction operation on daily basis in District Srinagar -Budgam-Ganderbal on the following terms and conditions:

- 1) The successful tenderer has to bear the expenses as well as remuneration of labourers during the Poppy/bhung destruction operation.
- 2) The successful tenderer has to bear any loss /injury which may occur to the labourers during the Poppy/Bhung operation and shall be himself responsible for the same.
- 3) The successful tenderer shall have to keep the labourers available at the disposal of the department or as per Poppy/Bhung destruction programme.
