SRO \\\ - In exercise of the powers conferred by sub-section (1) of section 3 of the Jammu and Kashmir Levy of Tolls Act Samvat 1995 (VIII of 1995), the Government hereby direct that there shall be exemption from Toll leviable under the said Act, on import/export of the following items:-

**1. Exemption on Import:**

- i. "Rice bran and wheat bran;
- ii. Milch Animals (Cows/Bufferaloes); and
- iii. Jute fabric imported by J&K State Women Development Corporation".

**2. Exemption on Export:**

"Bee-hives and Bee Colonies".

This Notification shall come into force w.e.f. 01.04.2011.
