## <u>Circular</u>

Whereas vide Government Order No. 05-F of 2006 dated: 03.01.2006, the Final Seniority List of 81 members of the Jammu & Kashmir, Excise & Taxation (Gazetted) Service as it stood on 01.08.2005 was notified;

Whereas the Seniority of the Officers mentioned at Serial No. 70 to 79 was subject to their successful completion of probation;

Whereas, the said Seniority List was challenged in the Hon'ble High Court by some members of the service figuring at Serial No. 70-79 with regard to assigning them the position ahead of the members from Serial No. 55 to 69;

Whereas, the Hon'ble High Court in SWP No.2356/2009, titled Rakesh Kumar and others Vs. State and others vide Judgment dated 07<sup>th</sup> of May, 2013 disposed of the writ petition, The operative part of the said judgment is as under:-

"The outer time limit for throwing challenge to the final seniority list as laid down in the case law noticed above is four year from the date of issuance/publication of the final seniority list. Though four years is not a legislatively fixed period for questioning final seniority list, yet the case law on the subject is suggestive of adherence to such time limit. In other words, challenge to final list after a period of four year should not ordinarily be entertained unless there are cogent and convincing reasons to justify the delay, in questioning such list. In the present case, petition in view of the facts and circumstances discussed cannot be said to be hit by delay and laches.

For the reasons discussed, there is merit in the writ petition. The petition is, accordingly allowed. The order No.232-F of 2004 dated 6th December, 2004 is quashed to the extent it give retrospective effect to the promotion of private respondents with effect from the date(s), the Excise and Taxation vacancies in promotional quota were available. The final seniority list bearing No.05-F of 2006 dated 3th January, 2006, is also quashed to the extent, it places the respondents (6-15) ahead of petition in the final seniority list. The official respondents are directed to reframe the final seniority list taking date of appointment by promotion of private respondents

effective from the date of order, where by they were so appointed was acted upon and not the date when the posts become available or were left vacant. The official respondents shall proceed further on the basis of final seniority list so drawn.

the judgement dated 07.05.2013 has been Whereas. challenged in LPA (SW) No.91/2013 and the Division Bench of the Hon'ble High Court vide order dated 10.05.2013 directed as under:-

> "Meanwhile, subject to objections and till next date before the Bench, the process of re-drawing of Seniority List may continue, but shall not be acted upon."

Whereas in pursuance of the directions of the Hon'ble High Court dated 07.05.2013 read with directives dated 10.05.2013, the Seniority List of the members of the service figuring at Serial No. 55 to 79 is required to be reframed:

Now, therefore the tentative Seniority List of the members of the Jammu & Kashmir, Excise & Taxation (Gazetted) Service as it stood on 01.08.2005 in respect of member of the services figuring from Serial No. 55 to 79, is hereby notified as Annexure 'A' to this Circular.

Objections if any in this regard should reach the Finance Department within 15 days from the date of issuance of this circular falling which, it will be presumed that the members of the services have not objections with respect to the assigned positions and the seniority shall be finalized accordingly.
