Sub: Transportation of liquor/furnishing of Excise Verification Certificates.

Ref: Recommendations of the Committee of Deputy Excise Commissioners conveyed by the Deputy Excise Commissioner, Executive, Jammu under No. DECJ/Exc/Min/5797 dated 10.12.2009.

C I R C U L A R

It is observed that Excise Officers posted at the Distilleries/Bottling Plants/Breweries in the State are not following uniform norms while prescribing time limit for transportation of liquor on Transport Passes issued against duty paid permits by the competent Permit Issuing Authorities. Therefore, in order to prevent mis-utilization of Transport Passes and in supersession of all previous instructions on the subject, it is hereby ordered that in future minimum time shall be allowed by the concerned Excise Officers for transportation of liquor from the manufacturing units to wholesalers (JKEL-1) which shall not in any case exceed the time limits indicated below:-

Similarly the Excise Officers posted at JKEL-1A will allow minimum time period for transportation of liquor to JKEL-1 Licensees keeping in view the distance/location involved. The Excise Officers posted at JKEL-1 shall likewise allow minimum time period for transportation of liquor to retailers keeping in view the distance/locations involved as per their best judgment as it is not practicable to prescribe point to point timeline at the State level.

Further, in order to ensure that all liquor transported on the basis of Permits/Transport Passes is properly accounted for, following time period shall be allowed for furnishing of '**Excise Verification Certificates**' from the Trade to Distilleries, JKEL-1 to JKEL-1A and from Retailers to JKEL-1:-

If the '**Excise Verification Certificates**' are not furnished by the laid down time lines no further permits/transport passes shall be issued in favour of the defaulting Licensees and matter brought to the notice of concerned Permit Issuing Authority for suitable action.

In case of export of liquor outside the State the procedure prescribed vide this office No.EC/Export-Permits/F-074/7141-45 dated 01.01.2010 shall continue to apply.

Any violation of these circular instructions shall be viewed seriously.
