Subject: Final Seniority list of Sub-Inspector of the Excise and Commercial Taxes Department.

Government Order No. 213 -F of 2012
D a t e d : 19 -09- 2012

Whereas, in order to update the seniority list of the Sub-Inspectors of Excise and the Commercial Taxes Departments, it is expedient to exclude the names of officials, who have either been promoted to the next higher post substantively or have retired on superannuation, and include those who have been appointed to the posts of Sub-Inspector through the authorized channel of direct recruitment/promotion;

Whereas, in order to update the seniority list, a tentative seniority list of Sub-Inspectors, indicating the position as on 01.01.2012, was notified vide Circular, dated 23.05.2012 wherein objections, if any, in the said list were invited from all concerned within a period of two weeks from the date of the issue of the Circular;

Whereas, seventeen representations have been received through the concerned Heads of Department, which have been scrutinized under rules and requisite amendments have been incorporated in the seniority list;

Whereas, Mr. Sheikhzada Muzaffar, has represented that his date of initial appointment is 19-06-2007 instead of it has been shown as 19-09-2007. After examination of the records, the claim of the official was found to be genuine, the necessary correction of his date of appointment has been made;

Whereas, one Mr. Manzoor Ahmad Khan and Mr. Qaisar Iqbal Qureshi, figuring at S.No. 120 and 121 of the tentative list have represented that their date of initial appointment is 20-12-2006, instead it has been shown as 21-12-2006. After examination of the records, the claim of the officials was found to be genuine, so the necessary correction of their date of appointments have been made;

Whereas, Mr. Varinder Singh, has filed an objection to the effect that his qualification has been mentioned as "Matric", instead of "M.Sc Economics". After examination of the testimonials submitted, the prayer made by the official has been found genuine, and accordingly the necessary correction of his qualification has been made;

Whereas, Mr. Mukhthar Ahmad Wani, has filed an objection that he belongs to "RBA category" which has not been mentioned against him in the list. After examination of the records the prayer made by the official has been found to be genuine, and accordingly RBA category has been mentioned in front of his name;

Whereas, Mr. Shabir Ahmad Wani, Sub Inspector has filed objection that his name does not figure in the tentative seniority list. Perusal of the records revealed that Shri Shabir Ahamad Wani was appointed in relaxation of rules as Sub-Inspector, vide Government order No.776/Adm dated: 02-12-1989, against a direct quota post, subject to the condition that he will qualify the departmental examination with in a period of two years, failing which his service were liable to be terminated. Since, the official yet has not qualified the departmental examination thus, could not figure in the seniority list of Sub-Inspectors as he yet not confirmed on post.

Whereas, Mr. Javid Ahmad Shah and Saqib Hussain Shah have represented that they have not been included in the tentative list. After examination of the records, the prayer of these officials has been found to be genuine and on the basis of their service particulars furnished by the Excise Department, as detailed below:-

Their names have been incorporated in the seniority list at S.No. 119 and 120 respectively;

Whereas, Shri Mohmmad Arif Naik and Shri Imtiyaz Ahmad Khan Sub-inspectors have filed objection to the effect that their academic qualification has been shown as Matric and 10+2 respectively instead of B.A Part-II and B.sc Part-I. Scrutiny of the testimonials reveals that the prayer made by these officials have been found

genuine, and accordingly the necessary correction of their qualification has been made;

Whereas, Shri Deepak has represented that he belongs to SC category and it has not been shown against his name in the list. The prayer made by the official has been found genuine and, the requisite category have been mentioned in front of his names in the seniority list;

Whereas, Shri Veeraj Rani and Anil Sharma, have filed objection to the effect that instead of BBM and M.sc their academic qualification has been shown as Matric and B.sc respectively. The prayer made by these officials has been found genuine, and the necessary correction of their qualification has been made in the list;

Whereas, Shri Anil Kumar Sub-Inspector, has filed objection to the effect that RBA category has not been shown against him. After examination of the category certificate submitted, the prayer made by the official has been found genuine and, the requisite category have been mentioned in front of his names in the seniority list;

Whereas, Shri Mehmood Ahmad Khan has represented that his name has been shown twice in the tentative seniority list i.e at S. No. 10 and 43, and requested for deletion of his name at No. 43. After examination of the records as well as his initial appointment order, the prayer made by the official was founds devoid of merits and accordingly his name at S.No. 10 in the seniority list has been omitted, thus he will figure at S.No. 42 in the seniority list;

Whereas, Shri Gurpreet Singh has represented that the sub-Inspectors shown at S.No. 61 to 70 in the tentative seniority list are junior to him and has requested for making the necessary correction in he seniority list. After examination of the records as well as his initial appointment order, the prayer made by the official was founds genuine and accordingly he has been placed at S.No. 61 in the seniority list i.e. below Mr. Behari Lal and above Mr. Jashan Singh; and

Whereas, Shri Towseef Mustafa and Shri Javed Iqbal II, have filed objections to the effect that their qualification has been shown as B.sc. and B.A instead of M.sc. and M.A respectively. After examination of the records it revealed that the plea of the officials was correct and the necessary correction to the extent of their qualification has been made in the seniority list;

Now, therefore, without prejudice to and subject to the outcome of writ petition cases, if any, pending in the Courts of Law, the Seniority list of Sub-Inspectors of the Excise and Commercial Taxes Department, depicting the position as on 01.01.2012, is hereby issued forming annexure to this Government Order.

In case any officials feel aggrieved with the position assigned to him, he is entitled to file a review petition, as per the relevant provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order.

The date(s) of birth recorded against the officials, in the seniority list, shall not be taken as authentic, and, shall be subject to the verification from Service Books/Matriculation Certificates.
