Reference: Letter No.EC/ Adm / Seniority of Guards /138, dated 16.04.2013, from Excise Department.

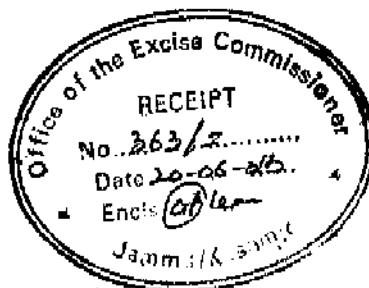
Whereas, vide Government Order No.186-F of 2012 dated 25.07.2012, Seniority list of Guards of the Excise and Commercial Taxes Department was notified, as it stood on 01.01.2012;

Whereas, the Excise Commissioner has forwarded the representation of Sh. Bilal Ahmad Kambay, Guard, presently placed as Incharge Sub-Inspector in the Excise Department, stating that he is not figuring in the seniority list of Guards, notified vide Government Order No. 186-F of 2012 dated 26.07.2012, though he is senior Guard of the Kashmir Division and has been appointed in the year 1997 and placed as Incharge Sub-Inspector vide Government Order No.299-F of 2007 dated 13.11.2007;

Whereas, the Excise Commissioner has requested for incorporation of his name in the seniority list of Guards at appropriate place on the basis of his substantive appointment as Excise Guard on 01.11.1997;

Whereas, Mr. Bilal Ahmad Kambay, was appointed substantively as Excise Guard on 28.10.1997 and has been working as Incharge Sub-Inspector, his name was inadvertently missed out while finalizing the seniority list of Guards of Excise and Commercial Taxes Department;

Whereas, after examining the request of Mr. Bilal Ahmad Kambay, Guard, Excise Department, It is desirable to incorporate his name in the seniority list of Guards at S.No.17-A i.e. below Mr. Ghulam Hassan Paul (seniority position 17) and above Mr. Ali Mohammad Dar (seniority position-18);


