Subject: Seniority list of Ministerial Staff of the Excise and Commercial Taxes Department.

Government Order No. 246 -F of 2012
D a t e d : 25 -10- 2012

Whereas, in order to update the seniority list of the Ministerial staff of the Excise and the Commercial Taxes Departments, it is expedient to exclude the names of officials, who have either been promoted to the next higher post substantively or have retired on superannuation, and include those who have been appointed to the posts of Sub-Inspector through the authorized channel of direct recruitment/promotion;

Whereas, in order to update the seniority list, a tentative seniority list of Ministerial staff, indicating the position as on 01.01.2012, was notified vide Circular, dated 25.04.2012 wherein objections, if any, in the said list were invited from all concerned within a period of two weeks from the date of the issue of the Circular;

Whereas, as many as twelve representations/ objection have been received from the Ministerial staff through the concerned Heads of Department;

Whereas, after examination of the Government Orders of their appointments, and their respective category certificates, the prayer made by these officials has been found genuine and, accordingly, the requisite categories, qualification and date of appointment have been mentioned in front of their names in the seniority list;

Whereas, Mr. Mohammad Hussain, Head Assistant (Divisional Cadre Jammu) has filed objection to the effect that his date of initial appointment is 03-11-1981 instead of it has been shown as 20-06-1981. After examination of the records the claim of the official is found genuine, and accordingly the necessary correction in his date of appointment has been made in the seniority list;

Whereas, Mr. Gian Singh, Senior Assistant (Divisional Cadre Jammu) has filed objection to the effect that he belongs to "RBA category" which has not been shown against him in the list. After examination of the records the prayer made by the official has been found genuine, and accordingly RBA category has been mentioned in front of his name;

Whereas, Mr. Kewal Krishen, Senior Assistant (Divisional Cadre Jammu) has filed objection to the effect that he belongs to "Social Caste" which has not been shown against him in the list. After examination of the records the prayer made by the official has been found genuine, and accordingly Social Caste category has been mentioned in front of his name;

Whereas, Mr. Ashni Kumar, Senior Assistant (Divisional Cadre Jammu) has filed objection to the effect that his name has wrongly been shown in the list as "Ashwani Kumar" while as his actual name is "Ashni Kumar. After examination of the records the prayer made by the official has been found genuine, and accordingly necessary correction has been made in his name in the seniority list;

Whereas, Ranju Kumari, Junior Assistant (Divisional Cadre Jammu) has filed objection to the effect that her seniority has been wrongly fixed in the list. After examination of the records the prayer made by the official has not been found genuine;

Whereas, Mr. Bhanu Partap, Junior Assistant, (Divisional Cadre Jammu) has filed objection to the effect that his name, qualification and Category has wrongly been shown in the list. As her actual particulars are as under:-

a) Qualification	B.sc
b) Name	Bhanu Pratap
c) Category	Scheduled Caste

After examination of the records as well as testimonials the prayer made by the official has been found genuine, and accordingly necessary correction/insertion regarding his name, qualification and category has been made in the seniority list;

Whereas, Mr. Vinay Dogra, Junior Assistant, (Divisional Cadre Jammu) has filed objection to the effect that his qualification as B.sc "Social Caste" category has not been mentioned in the list. After examination of the records/testimonial the prayer made by the official has been found genuine, and accordingly his qualification and category has been mentioned in front of his name;



Whereas, Mr. Vikas Sadhotra, Junior Assistant (Divisional Cadre Jammu) has filed objection to the effect that that his Surname and qualification has wrongly been shown in the list. As his actual Surname is "Sadotra" and qualification is "M.sc". After examination of the records/testimonial the prayer made by the official has been found genuine, and accordingly necessary correction in hfs surname and qualification has been made in the seniority list;

Whereas, Mr. Vijay Kumar, Mr. Bachan Lal and Mr. Joginder Singh, Junior Assistants, have claimed that their names have not been shown in the seniority as they are holding the post of Junior Assistants since 1999. The claim of these officials has examined in light of the report of the Commercial Taxes Department which provides that these official were promoted in the year 1999 as Junior Assistants subject to confirmation by Departmental promotion committee, but till date these officials have not been confirmed by the departmental promotion committee. So their claim for incorporating them in the list of Junior Assistants does not have any merit;

Whereas, Mr. Khursheed Ahmad, Cashier (Divisional Cadre Kashmir) has filed objection to the effect that his name is not figuring in the tentative seniority list, therefore, has requested for inclusion of his name in the list. The claim of the official has examined in light of the report of the Commercial Taxes Department which provides that the official has been promoted as Cashier w.e.f 15-07-2009, and his name should be figuring at S.No. 08 in the list of Head Assistants of Divisional Cadre Kashmir, therefore, Mr. Khurshed Ahmad Cashier (Divisional Cadre, Kashmir) has been in the list of Head Assistants at S.No. 8 i.e. above Mr. Ghulam Nabi Sheikh and below Mr. Devinder Singh Head Assistants.

Now, therefore, without prejudice to and subject to the outcome of writ petitions cases, if any, pending in the Courts of Law, the final Seniority list of Ministerial Staff of the Excise and Commercial Taxes Department, depicting the position as on 01.01.2012, is hereby issued forming annexure to this Government Order.

In case any official feels aggrieved with the position assigned to him, he is entitled to file a review petition, as per the relevant provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order.



The date(s) of birth recorded against the officials, in the seniority list, shall not be taken as authentic, and, shall be subject to the verification from Service Books/Matriculation Certificates, Reserved Category Certificates shall also be subject to verification from the concerned issuing authorities.
