SUB: - Regulation of operations of Wholesale trade JKEL-1 and JKEL-1A.

EXCISE O R D E R N O. 105 -STS OF 2005

D A T E D: - 31-05-2005

Whereas, a wholesale trade JKEL-1A is supposed to supply liquor to a wholesale trade JKEL-1 who in turn is supposed to supply liquor to retailers holding licenses in form JKEL-2, JKEL-3, JKEL-4, JKEL-4A, JKEL-4B, JKEL-4C, JKEL-4D, JKEL-4E, JKEL-7 and JKEL-7A only.

Whereas, it has come to the notice of this office that transactions of liquor within wholesale trade JKEL-1 are taking place unauthorizedly.

Now, therefore, for better regulation of activities in liquor trade, it is hereby ordered that: -

1. Import permits shall be issued by the Deputy Excise Commissioner, Executive, Jammu after receipt of Excise Duty & Import fee etc. for import of liquor from outside the state by the wholesale trades holding license in form JKEL-1A. The JKEL-1A licensees shall supply liquor imported from outside the state to JKEL-1 licensees only for which purpose transport permit/pass shall be issued by the excise personnel posted in the concerned trade viz JKEL-1A.
2. JKEL-1 licensees shall supply liquor to retailers holding license in form JKEL-2, JKEL-3, JKEL-4, JKEL-4A, JKEL-4B, JKEL-4C, JKEL-4D, JKEL-4E, JKEL-7 and JKEL-7A only for which purpose transport permit/pass shall be issued by the excise personnel posted in the concerned trade viz JKEL-1.
3. For supply of liquor from local manufacturers to the JKEL-1 licenses irrespective of their location at a place in Jammu Division



or Kashmir Division, requisite permits / transport passes shall be issued by the Deputy Excise Commissioner, Distilleries, Jammu only after receipt of Excise Duty etc.

4. No transaction shall take place between the same category of licenses in wholesale (Viz JKEL-1A to JKEL-1A or JKEL-1 to JKEL-1). Further more no transaction shall take place between any of the retailers. However, a JKEL-1 licensee can supply imported liquor brought directly from outside the state from importers / bottlers of such liquor to a fellow JKEL-1 licensee. Every JKEL-1 trade licensee is free to bring such imported liquor directly from Importers/ bottlers without routing through JKEL-1A.
