Additional Commissioner Commercial Taxes, Adm. Jammu vide his letter No: 28/DPC/Accts/Adm/83-84 dated: 23-04-2013, has forwarded the minutes of the Departmental Promotion Committee meeting held on 28-03-2013. Wherein among other decisions the Departmental Promotion Committee has cleared promotion of 20 Guards as Head Guards/Armed Head Guards and recommended their cases to the Excise Commissioner and Commissioner Commercial Taxes department for issuance of their promotion orders. Out of 20 Guards, 16 Guards belonging to the Excise department. The case of one Guard falling at Sr. 15 of the minutes of the meeting is subjudice in the Hon'ble Court and is not considered for promotion, there remains only 15 Guards of Excise department.

Whereas some Excise Guards aggrieved by the decisions of the Departmental Promotion Committee, filed a writ petition bearing SWP No: 990/2013 and CMA Nos. 1551/2013, 1405/2013 and 2332/2013 titled as Mohd. Farooq and Others V/s State and Others before Hon'ble High Court at Jammu. The Hon'ble High Court passed an order dated: 03-05-2013, the concluding para of which is reproduced here under:

"Notice and appearance as under.

In the meanwhile, subject to objections from other side and till next date of hearing respondents are directed to maintain status quo as on date...."

Whereas in light of the above Court Orders this office has not issued the promotion orders in respect of the Guards belonging to this department cleared by the Departmental Promotion Committee in its meeting held on 28-03-2013.

Whereas the Commercial Taxes department has issued the promotion orders in respect of the Guards belonging to the said department prior to the Court order dated: 03-05-2013 vide their Order No: 93/Adm of 2013 dated: 26-04-2013.

Now, the Hon'ble High Court passed an order dated: 11-11-2013 in the above titled case wherein status quo has been vacated and the impugned promotion of the private respondent shall remain subject outcome of the writ petition.

Now, therefore, as approved by the Departmental Promotion Committee in its meeting held on 28-03-2013 sanction is hereby accorded to the promotion of following Excise Guards as Head Guards/Armed head Guards in the Pay Band of `5200-20200 + Grade Pay of `1900/-w.e.f 28-03-2013.
