NOTIFICATION  
JAMMU, THE 29<sup>th</sup> February, 2004.

SRO 64.- In exercise of the powers conferred by section 16 read with section 17 of the Jammu and Kashmir Excise Act, Samvat 1958, the Government hereby direct that in Notification SRO 204 dated 26<sup>th</sup> June, 2003, the following amendments shall be made, namely:-

- (1) In item No. 1-A the following shall be added as entry (iii) and the existing entries (iii) and (iv), shall be re-numbered as (iv) and (v) respectively:-

(iii) -do- JK-Desi Whisky Rs. 125/- per LPL

- (2) In item No. 5 the entries appearing at S.Nos. (iii), (iv) and (v) shall be substituted by the following respectively: -

(iii) Retail JKEL-2 / *at* Rs. 2.00 lacs per annum

(iv) Bar with Hotel JKEL-3 Rs. 1.00 lac per annum

(v) Bar with Restaurant or Cinema  
or Theatre or Dak Banglow  
JKEL-4 Rs. 1.00 lac per annum

- (3) After item No. 5 the following shall add as item No.5-A; namely:-

**5-A Additional Licence Fee**

Additional licence fee for each bottle of 750 ml shall be charged from the following categories of licences at the rates indicated each:-

- (i) Retail JKEL-2

IMFL ( Except JK-Desi Whisky)

Sale upto 15000 bottles of IMFL = Nil

Sale between 15,001 to 50,000 bottles of IMFL = @ Rs. 10/- per bottle of 750 ml

Sale between 50,001 to 1,00,000 bottles of IMFL = @ Rs. 12/- per bottle of 750 ml

Sale above 1,00,000 bottles of IMFL = @ Rs. 14/- per bottle of 750 ml

- (ii) Bar with Hotel JKEL-3

IMFL ( Except JK-Desi Whisky)

Sale above 10,000 bottles of IMFL = @ Rs. 10/- per bottle of 750 ml

- (iii) Bar with Restaurant or Cinema or Theatre or Dak Bungalow JKEL-4

IMFL (Except JK-Desi Whisky)

Sale above 10,000 bottles of IMFL = @ Rs. 10/- per bottle of 750 ml

The Additional Licence Fee payable shall be paid on monthly basis as soon as the threshold limit is crossed in accordance with the procedure to be prescribed by the Excise Commissioner.

This shall come into force with effect from 01.04.2004
