SRO 35.-In exercise of the powers conferred by Section 5 of the Jammu and Kashmir Levy of Tolls Act, Samvat 1995(VIII of 1995), the Government hereby direct that below para (iii) to Notification SRO 22 dated.31.01.2004, following provisos shall be added:-

"Provided that there shall be no additional toll chargeable on capital goods to be imported by the existing industrial unit (directly linked to the manufacturing process) for substantial capacity expansion, for period of one year with effect from 01.04.2008 to 31.03.2009.

Provided further that such exemption shall be available only on import of capital goods, which are not available locally and is certified as such by the concerned authority at the Toll Post. "

This notification shall come into force with effect from 01.04.2008.
