

In terms of S.O. 326 dated 21<sup>st</sup> September, 2021 and concurrence given by the Finance Department vide letter No. FD-ESTB/81/2021-09/FD dated 22-09-2021, and in the interest of Government revenue, the licenses granted under J&K Liquor License & Sale Rules, 1984 (except JKEL-2) which were operational on 30-04-2021 in terms of Circular issued by this office vide No. EC/Exc/Ren.2021-22/Main/7865-82 dated 31-03-2021, are hereby extended upto 31-12-2021, subject to condition that is nothing outstanding against the licensee and deposition of license fee.

The Deputy Excise Commissioner, (Executive) concerned and the Excise & Taxation Officers concerned shall get all the prescribed formalities completed by the licenses within a period of 3 months i.e. upto 30-11-2021 for formal renewal of the licenses.
