

## AFFIDAVIT

Bidder shall submit an affidavit duly executed before Magistrate in the following format along with e-bid:

- i. That I am a domicile of the Union Territory of Jammu & Kashmir.
- ii. That I fulfill all the eligibility conditions as laid down in Para 2.3.3 of the J&K Excise Policy 2025-26 and para VI of the Bid Document issued thereunder.
- iii. That I have not been convicted of any non-bailable offence by a criminal court.
- iv. That I have not been convicted, or reasonably suspected of committing or conniving for the commission of any non-bailable offence under the J&K Excise Act, Svt. 1958 or NDPS Act, 1985 and shall produce a character certificate issued by the concerned District Superintendent of Police for issuance of License.
- v. That I have not been a defaulter of State Taxes Department under the J&K General Sales Tax Act 1962, Central Sales Tax Act and J&K Excise Act Svt. 1958.
- vi. That I am in possession/have made arrangements for ensuring availability of premises on ownership/Lease/rent deed duly registered for the location for which bid is offered.
- vii. That I have submitted only one bid for the given location whether in my individual capacity or in partnership or as member of cooperative society or Director of Company or its representative.
- viii. That I have paid Registration fee, EMD and shall deposit Bid Amount from my own KYC/PAN linked bank account(s).
- ix. That grant of JKEL-2 License in my favour is not in conflict with para 4 of the J&K Excise Policy 2025-26, Rule 18, 19(1) and 19(2) of J&K Liquor License and Sale Rules.
- x. That I am not a defaulter of the J&K Excise Department.
- xi. That I have not been debarred from holding license for the sale of any intoxicant in J&K, Punjab, Delhi, Haryana, UT of Chandigarh or Himachal Pradesh.
- xii. That I have bid as individual/partner/director/member (as applicable). The partnership deed/registration/resolution (as applicable) have already been made before bidding.

- xiii. That I am in possession of Solvency/Immovable Property Certificate as per Para VI (c) of Bid Document and shall submit the same in terms of 2.3.3(c), 2.3.8 of the J&K Excise Policy 2025-26.
- xiv. That I shall submit the copy of Bank Guarantee as required under Para 2.3.3(c) of the J&K Excise Policy 2025-26 and para VI (c) of the Bid Document.
- xv. All the documents submitted/uploaded or to be submitted subsequently by the deponent are/shall always be bonafide and correct and I shall be solely liable to be proceeded against under relevant Rule/Law/Act in case of any omission/commission /default/misrepresentation of documents/facts.
