**Subject:** Conduct of General Elections to the Legislative Assembly of Himachal Pradesh 2022-Declaration of Dry Days-Regarding.

In view of above referent communication of the Chief Electoral Officer, Union Territory of J&K & Ladakh, regarding conduct of General Elections to the Legislative Assembly of Himachal Pradesh, 2022, all the liquor vends/trades/outlets selling liquor on/off the premises operating within 3 KMs area of the UT of J&K, adjoining the Assembly Constituencies of the State of Himachal Pradesh, shall observe dry days from 5:00 PM on 10-11-2022 till 05:00 PM on 12-11-2022 and on the date of counting i.e. 08-12-2022. Any permit issued prior to this Order to serve liquor on social occasions at private places, banquet halls, party halls, restaurants within the same distance on ibid dry days, stands cancelled.

Further, the Officers and Field Staff of the Excise Department shall lay Nakas at the entry points from State of Himachal Pradesh and Lakhampur to prevent inter-state smuggling of liquor, if any, on the afore-mentioned days.

The Excise & Taxation Officer, Excise Range Kathua, Nodal Officer shall be the overall Incharge of observance of dry days and laying Nakas on the aforesaid dates.
