Whereas, Chief Electoral Officer, J&K vide afore-referred letter has enclosed directions of the Election Commission of India regarding announcement/notification of the General Elections to Legislative Assemblies of Haryana and Union Territory of Jammu & Kashmir, 2024 vide its Press Note No. ECI/PN/128/2024 dated 16.08.2024; and

Whereas, the Chief Electoral Officer, J&K has communicated vide afore-referred letter mentioning date(s) of poll and date of counting for declaration of Dry Days within the Assembly Constituencies on the scheduled dates of polling and date of counting in respective Assembly Constituencies; and

Whereas, Election Commission of India vide its Press Note No. ECI/PN/132/2024 dated 31st August, 2024 has decided to change the date of counting for the UT of Jammu & Kashmir from 04.10.2024 to 08.10.2024 (Tuesday); and

Whereas, Section 135-C of the Representation of People Act, 1951 provides that:

"No spirituous, fermented or intoxicating liquor or other substances of a like nature shall be sold, given or distributed at a hotel, eating house, tavern, shop or any other place, public or private, within a polling area during the period of forty-eight hours ending with the hour fixed for the conclusion of the poll for any election in the polling area."

Now, therefore, in exercise of powers conferred under clause (i) of sub rule (10) of Rule 38 of the J&K Liquor License & Sales Rules, 1984, it is hereby ordered that 'Dry Day' shall be observed in each respective Assembly constituency on polling dates (48 hours ending with the hour fixed for conclusion of poll) and counting date as per the below schedule mentioned against each Assembly Constituency in the UT of J&K.



Further, the following shall be strictly observed within the Assembly Constituencies on the Dry Days as per afore-mentioned schedule:

- 3/9
- The liquor shops/Liquor Bars/Liquor Trades, operating within the respective Assembly Constituencies on the designated dry days shall remain closed as per schedule.
 - No liquor shall be served in Hotels, Restaurants, Clubs and other establishments located within the respective Assembly Constituency on scheduled dry days.
 - Non-Proprietary Clubs, Star Hotels, Restaurants etc. and Hotels functioning under different categories of licenses for possession and supply of liquor shall not be permitted to serve liquor on the scheduled dry days within the respective Assembly Constituencies as per schedule.

d) Any permit to serve liquor on social occasions at Private Places, Banquet Halls, Party Halls and Restaurant etc. issued by competent authority prior to the issuance of this Order shall be deemed to have been cancelled ab-initio.
