Classification of Local & Imported IMFL brands for sale in Civil Market/Sale to Paramilitary Forces and fixation of MRP of Local Beer brands & Local IMFL brands for Sale in Civil Market in UT of Jammu & Kashmir for the year 2021-22.

Whereas, the committee constituted vide Order No. 37 EC of 2020 dated 06-06-2020 forwarded the Minutes of Meeting bearing No. DECAJ/Exc/Acctts/800-07 dated 12-02-2022 held on held on 31<sup>st</sup> January & 3<sup>rd</sup> February, 2022; and

Whereas, in light of S.O. 114 dated 31-03-2021 (Excise Policy 2021-22) and report of Departmental Chemist the committee recommended the classification and fixation of brands; and

Whereas, the Deputy Excise Commissioner (Accounts), Jammu vide Order No. 310-EC of 2022 dated 02-03-2022 issued under endorsement No. EC/Exc/MRP-IV/2021-22/8296-8317 dated 02-03-2022 was requested to re-examine the issue of classification of brands "Charlie White Rum", "6 Bullet Whisky", "Red Bliss Virgin Vodka" in the committee and recover the prescribed labels fee for classification/fixation of MRP of brands of M/s Oakland Bottlers Pvt. Limited, Plot No. 19, SIDCO Industrial Growth Centre, Samba, J&K and M/s Devans Modern Breweries Ltd. Samba, J&K; and

Whereas, the committee constituted vide Order No. 37 EC of 2020 dated 06-06-2020 forwarded the Minutes of Meeting bearing No. DECAJ/Exc/Acctts/885-91 dated 09-03-2022 held on 03-03-2022 wherein the committee has recommended the following cases:

- (i). The strength of brand "Charlie White Rum" has inadvertently written as "65° Proof/37.14% Adv." instead of "75° Proof/42.8% Abv." The committee has requested to read strength of brand "75° Proof/42.8% Abv." instead of "65° Proof/37.14% Adv.".
- (ii). The label fee of Rs 50,000/- with respect to the brand "Fentasy Gin" of M/s Oakland Bottlers Pvt. Limited, Plot No. 19, SIDCO Industrial Growth Centre, Samba, J&K has been remitted by the licensee vide Collection ID 211229175624YQS dated 29-12-2021.
- (iii). The label fee of Rs 50,000/- with respect to brand "Six Fields Rebel Premium Dark Ale" of M/s Devans Modern Breweries Ltd. Samba, J&K has

been remitted by the licensee vide Collection ID 220304111710CEN dated 04-03-2022.

Whereas, the committee has also recommended fixation of MRP of Local IMFL "Medium" brands i.e. one brand of M/s Kashmir Bottlers, Phase-I, SIDCO, IGC, Distt. Samba, J&K for M/s Radico Khaitan Limited, Bareilly Road, Rampur, U.P.-244901 and one brand of M/s Tawi Bottlers, Sujwan, District Samba, J&K for M/s Mohan Meakin Limited as per Annexure – "A-52". The brands stands classified vide Order No. 310-EC of 2022 dated 02-03-2022.

Now, therefore, in exercise of the powers conferred under Rule 38, sub rule 31 clause (b) sub clause (iv) of the J&K Liquor License and Sale Rules, 1984, read with S.O. 114 dated 31-03-2021 and recommendations of the committee constituted vide Order No. 37 EC of 2020 dated 06-06-2020 sanction is hereby accorded to the classification of below mentioned IMFL brands in "Premium" segment/category meant for Sale in Civil Market/Sale to Paramilitary Forces in UT of J&K and fixation of exmanufacturer price, ex-wholesale (JKEL-1) price and Maximum Retail Price of Local Beer brand as per Annexure-"A-40", Annexure-"A-41" & local IMFL brands as per Annexure-"A-52", and fixation of ex-manufacturer price per Keg of Local Draught Beer as per Annexure-"A-42" to this order for the year 2021-22. The brands shall not be sold above the fixed rate:
