Jammu, the 25th March 2008

SRO 87.-In exercise of the powers conferred by Section 5 of the Jammu and Kashmir Levy of Tolls Act, Samvat 1995(VIII of 1995), the Government hereby make following amendments in Annexure 'A' to Notification SRO 22 dated .31.01.2004: -

1. Entry No.6 shall be recast as: -
"Empty bottles (excluding all types of glass bottles)"
2. At the end of entry No. 8, after the words "*per piece*", the words "*except locally extracted and processed marble stones*" shall be added.
3. Entry No. 19 shall be recast as: -
"Oil cakes, Wheat bran, Maize bran and Rice bran except when imported for manufacture of poultry and cattle feed" by the units.

This notification shall come into force with effect from 01.04.2008.
